In the name of God Amen the 18th daye of March AD 1604 and in the year of the raigne of our Sovereigne Lord James by the grace of God King of England France & Ireland the second & of Scotland the eiyght & thinketh Defender of the fayth I Elizabeth Campe Of Nasinge in the countie of Essex widowe being in good and perfect health I thank my Lord God yet waying with my selfe the frayltye of my life by reason of infirmaties growing upon mee, and to set all things at quiet, as touching my worldlie estate which God in his great mercy hath lent mee wherby noe troble might aryse after my death do make this my last will & testament renouncing & revoking herby all former wills by mee made or pounced by writing or by word, First & principally I bequeath my soul unto almightie god most stedfastly believinge by the most pretiouse deutye & bloodshed of our Saviour Jesus Christe to have free remission of all my sinnes & therby to be saved & my bodie bequeathed unto earthe as earthly to be buryed in the parish church of Nasinge aforesaid according to the discession of my executors here undernamed. And as touchinge my lands I doe will & bequeath my six acres of land in Parndon in the said countie of Essex, be it more or lesse with the appurtenances unto my sonne Francis Campe to have & to hold to hime & to his assignes during his naturall life & after his decease I will the same landes with the appurtenances unto his twoe daughters Marye Campe & Jane Campe & to their heirs & assignes for ever provided allwaies & my mind & will is, yf it shall happen ether of them to die before shee shall accomplish ther full age of twentie & one yeres That then the said lands shall descend to the survivor of them & to her heirs & assignes for ever. *Item* I doe will & bequeath unto the poore people of Nasinge aforesaid twentie shillings of lawfull english monie to be distributed amongst them on the day of myburiall, *Item* I will & bequeath unto my honest neighbours parishioners of Nasinge to be bestowed in a dinner amongstthem ye somme of twentie shillings of like monie, *Item* I doe give & bequeath unto my sonne Willyam Campe the chest that doth stand at my beds feete & also one paire of flaxen sheetes, *Item* I doe give & bequeath to the five children of my sonne Thomas Campe being four sonnes & one daughter three shillings & foure pence a piece of like lawfull money of England, *Item* I give & bequeath to the foure children of my sonne Curtis being one sonne & three daughters three shillings & foure pence a piece of like lawfull money of England, *Item* I doe give & bequeath towards the reparacons of the parishe church of Nasinge aforesaid sixe shillings & eight pence of lawfull english money. The residue of all my goods cattells & money whatsoever my debts being paied legacies performed & funeralls discharged I give & bequeath unto my twoe sonnes Francis Campe & Henry Campe whom I doe ordaine & make executors of this my will & testament. I doe desire them that they will duely & trewly performe this my last will & testament in all poynts according to my expresse meaninge. And I doe nominate & appointe my lovinge frends George Duckett & Nicholas Campe overseers of this my laste will & testament, desiring them as my trust & confidence is in them for soe much as in them lyeth to see soe this my said will in all points performed as aforesaid. And I do give & bequeath unto my my said overseers as a token of my good will for there paines & care to be taken here in six shillings & eight pence a piece of like lawfull money of England.
