I doe make & ordaine ioent Executrixes of this my Last Will & testament hearby Revoking & making void all other former Willes whatsoever And lastly I doe apoynt John Bridges of Waltham hollicrose Butcher & William Campe of Nazing Yeoman to be overseers of this my Last Will & Testament desireing they will see the same performed & I doe give them twordes there paines five shillinges a peece
