In the name of God Amen ye XX day of December in the XXXIIIth year of the Reaigne of our Sovereigne Lady Quene Elizabeth. I Nicolas Campe the elder of Nasing in the countie of Essex Carpenter beyng in goo & perfecte remembrance God have the prayse do make & ordayne this my last will & testamente in maner & forme following. First I bequeath & give my soule into the handes of my lorde god who gave me it & my bodye to the earth from whence it was taken wyth ioyfull & good assurance that I shalle raysed up agayne at the Last daye with the last to lyffe Everlasting & lyve with loard in glorie for ever. Concerning my worldly goodes I doe Dyspose of them as followeth. First I give to Nycolas my sonne forever two leases lying in Nasing Marshe also I give to my sonne Nycolas Campe twoe trowere? one olde Cheste all my two trower? One olde Cheste all my chesmottes?? and all the presses about the house. I give allso to Nycolas my sonne all my toolles that belong to my occupacion with atable & aforme & all the Hanginges in the Haalle. I give him two ashen Chaires & lytle Joined stolle. I give to Kathern my Daughter one payre of cobbornes spytte my best trevet my fyxe Jacke my brasse peste my posnet of peote brass my brassens mortar with the pestle a walnut tree Chaire in the hall a greate Joyne stoole Also I give her my cubborde in the chamber with three Chestes one long Elme Chest one oken? Chest & one Elme Cheste with a new locke the bedstedle that lye on. I give to Robert Pigerames wyfe 18/- I give to Margerie Robenson 18/- I give to the poore in the paryshe of Nasing 10/- All this rest of my goodes unbequeathed watsoever I wholly give to Nycolas my sonne & Kathern my Daughter divided betwene them and Kathern my Daughter to have the fyrst Chusse. I give to Nycolas my sonne all my Debts to paye all my Debtes and Legicies & to descharg my feneralls making him my whol executor of this my last will & testemente & I give him for his paynes vi s / viii d And I doe desir my brother Richarde Campe to be my overseere of this my Last Will and testement and doe give for his paynes iii s / iiiii d.
